## Terms and Conditions

1. Event management reserves the right to accept or reject each application.
2. **Beer Vendors will bring 2 to 4 New/Seasonal styles of beer, as requested by event director, in the barrel sizes and prices agreed upon.**
3. **Your beer should be brought in your own prearranged vehicles. Upon request, it is not likely, but not impossible to have access to our on-site refrigerated truck between 12pm and 4pm on the Friday before the event. Must confirm with director.**
4. **You will be serving 1-2 oz samples to guests with appropriate wristbands, and a 10-12oz “full pour” serving to appropriately banded guests who present official Full Pour Beer Tickets, which must be destroyed upon fulfillment.**
5. **Event staff will furnish a copy of our local event liquor permit.**
6. **There are several SPONSORSHIP OPPORTUNITIES Available. Please inquire.**
7. **Deposits/Payments for beer will be coordinated with event director independently.**
8. All participants must operate on Saturday, March 16, 2024 from 1:00pm-7:00pm and/or Saturday, October 5, 2024 from 2:00pm – 9:30pm
9. If bringing your own tent, please see that it is certified fire resistant. ALL TENTS MUST WE WEIGHTED DOWN or they will be taken down.
10. Application deadline is Feb 9, 2024.
11. All accepted applicants will be notified via the mail or email. We will send detailed festival information to applicants as they are accepted. Further information will be sent a couple of weeks prior to the festival.
12. THE FESTIVALS WILL GO ON RAIN OR SHINE. All vendors should have a substantial canopy or other protection for themselves. Once accepted, vendor fees are not refundable.
13. Liability Insurance: Susceptible vendors (alcohol, food, etc.) are encouraged to provide liability insurance, naming Interstate Festival Group and IFG Consulting LLC and Washington County Board of County Commissioners and the Washington County Agricultural Education Center as co-insured.
14. Each vendor will be responsible for his/her property. Interstate Festival Group, IFG Consulting LLC and Washington County Board of County Commissioners and the Washington County Agricultural Education Center and its staff and underwriters are not responsible for any damage, theft, injury, or loss for any reason.
15. Security will be provided by event staff. Security will be on-site on Saturday from three hours prior and one hour after each event.
